'If Gen Z Is Agitating, They Aren't Anti-Nationals'

RSS Chief Mohan Bhagwat Calls For Dialogue With Youth

New Delhi: RSS chief Mohan Bhagwat on Thursday said young people raising their voices over issues affecting them should not be branded as anti-national, stressing that their concerns must be heard and addressed through dialogue and democratic processes. Speaking at the International Movement to Unite Nations (IIMUN) Annual Championship Conference at the Nita Mukesh Ambani Cultural Centre (NMACC) in Mumbai, Bhagwat interacted with members of Gen Z and Gen Alpha during an event attended by more than 2,000 students from over 100 cities across the country. The event marked the 15th anniversary celebrations of IIMUN and focused on the theme, "The Role of Youth in Uniting the World, the Indian Way." Addressing recent student protests, Bhagwat said the younger generation was not seeking conflict but was instead trying to draw attention to genuine concerns. "If the Gen Z is agitating, they cer-



tainly aren't anti-nationals; they are our own people, our next generation," the RSS chief said. Without directly naming any movement, Bhagwat's remarks came against the backdrop of recent student-led protests in Delhi that culminated in the resignation of Union Education Minister Dharmendra Pradhan.

Emphasising the importance of debate in a democratic society, Bhagwat said protest was a legitimate means of building

consensus when grievances remained unaddressed. "In democracy, protest is also a method to have consensus. Dialogue is the first step, but if voices are not heard, people have the right to agitate. However, agitation should be aimed at correcting the system, not creating divisions," he said. Bhagwat also highlighted the changing mindset of younger generations, saying Gen Z and Gen Alpha were more in-

clined to question authority and demand logical explanations. Reflecting on the contrast with earlier generations, the 75-year-old leader said young people today expect reasoned answers rather than unquestioning obedience. He compared modern democratic discourse with the Indian tradition of "shastrarth", a process of debate and exchange of ideas aimed at discovering truth through multiple perspectives.

Israeli Prime Minister Benjamin Netanyahu Dials PM Modi, Discusses Developments In West Asia

New Delhi: Prime Minister Narendra Modi on Thursday received a telephone call from his Israeli counterpart Benjamin Netanyahu and they exchanged views on the recent developments in West Asia. The two leaders also reviewed sustained progress in India-Israel Special Strategic Partnership and reaffirmed their commitment to further strengthening the bilateral cooperation across various sectors for the mutual benefit of the two countries, a statement issued by the Prime Minister's Office said. "PM Netanyahu and PM Modi exchanged views on the recent developments in West Asia. The two leaders agreed to remain in touch," the statement said. The conflict in West Asia is continuing for over five months now without any permanent solution. Iran on Thursday said it is in the final stage of drafting an agreement on the Strait of Hormuz waterway with Oman, while two Israeli soldiers have been killed in Lebanon. The Strait is crucial to global shipping and energy supplies. Before the war, which began with US and Israeli strikes on Iran in February, around one-fifth of the world's oil and natural gas would pass through the waterway at the mouth of the Persian Gulf.



'I'm Your Boss, That Makes It Simpler': What Tarun Tejpal Told Woman He Raped

Mumbai: As Tarun Tejpal was convicted and then sentenced to 10 years in prison on Thursday for raping a junior colleague, one of the key pieces of evidence presented by the prosecution was an email the Tehelka Magazine founder and former editor had written to her after the crime. Tejpal was accused of sexually assaulting the woman on November 7 and November 8, 2013, in an elevator at a five-star hotel in Goa during the 'ThinkFest' event organised by the magazine. He was acquitted by a trial court in May 2021, but the Goa government appealed against the order in the Bombay High Court, which set aside the acquittal and convicted him. During the hearing, Solicitor General Tushar Mehta referred extensively to an email sent by Tejpal to the survivor after the incidents.



Jagan Creating Destruction and Lawlessness in the Name of Condolence Visits: Home Minister Vangalapudi Anitha

From Our Staff Reporter Amaravati, August 6: Andhra Pradesh Home Minister Vangalapudi Anitha launched a sharp attack on YSR Congress Party (YSRCP) president Y.S. Jagan Mohan Reddy, accusing him of creating unrest and destruction in the name of condolence visits following his party's defeat in the 2024 Assembly elections. Addressing the media, Vangalapudi Anitha gave a presentation highlighting what she described as the destruction caused during Jagan Mohan Reddy's tours. She also displayed videos allegedly showing incidents of violence and disorder during his visits. She alleged that the "axe party president" was troubling poor people for political gains. According to her, three people had lost their lives during Jagan Mohan Reddy's tours over the past two years. She accused him of creating destruction and lawlessness under the guise of condolence visits and said his "fake sympathy tours" were causing hardship to the public.

The Home Minister said that people are capable of distinguishing between good and bad leadership and have witnessed two completely different styles of governance over the last two years. Vangalapudi Anitha praised Chief Minister N. Chandrababu Naidu, stating that he works nearly 18 hours a day for the state's development. She said his efforts had brought industries and investments to Andhra Pradesh and that the Central Government was also extending full support to the state's development.



In contrast, she alleged that whenever Jagan Mohan Reddy steps out, destruction and lawlessness follow. She claimed women do not feel safe during his visits, ordinary people are unable to carry on with their businesses, and even police personnel are allegedly threatened and blackmailed. She further alleged that unable to tolerate the state's development, Jagan Mohan Reddy was creating public inconvenience under one pretext or another. She urged people to carefully observe the kind of leaders shaping the future of their children.

The Home Minister said the Opposition has every democratic right to organize protests and demonstrations but insisted that its leaders should raise responsible questions, assuring that the government would respond appropriately. She also questioned whether Jagan Mohan Reddy was undertaking any activity that genuinely benefited the people. Speaking about the withdrawal of the Disha Bill, Vangalapudi Anitha said that during the YSRCP government, Disha Police Stations had been established and responsibilities as-

signed to police officers even without a formal Disha law. She questioned why fingerprint authentication equipment had not been provided to the police during Jagan Mohan Reddy's tenure. She said the police themselves determine crowd estimates and barricading arrangements during Jagan Mohan Reddy's tours and stressed that laws apply only to those who respect them. She questioned why the YSRCP leadership was not following the rules and alleged that Jagan Mohan Reddy was coming out only to create unrest. She further alleged that before the 2019 elections, Jagan Mohan Reddy had sought "one chance" and later created an atmosphere of lawlessness. She claimed that during the YSRCP government, people lived in fear every Friday, uncertain about who would be sent to jail. Vangalapudi Anitha said the NDA coalition government had carried out so many development and welfare initiatives that even several pages would not be enough to list them all. She alleged that Jagan Mohan Reddy could not bear to see Andhra Pradesh's development and disturbances wherever he travelled.

'Two Minutes are enough to Control Jagan & Co.': CM

From Our Staff Reporter Amaravati, August 6: Andhra Pradesh Chief Minister N. Chandrababu Naidu chaired a Cabinet meeting at the State Secretariat on Thursday. During the meeting, the Chief Minister issued directions to ministers on several key issues and held discussions for nearly three-and-a-half hours. He also instructed ministers and NDA alliance leaders to remain prepared for the upcoming local body elections.

Chandrababu Naidu said that "two minutes are enough" for him to control Jagan & Co., but alleged that they were committing crimes under the guise of politics. He said everyone was observing the controversy being created over

the DSC recruitment process and added that the government had already explained every aspect of the DSC to the public. He criticized YSR Congress Party (YSRCP) leaders, saying they had even faced criticism from the courts but were still continuing their protests. Questioning the party's agitation over DSC, he said YSRCP leaders lacked even a basic understanding of reservation policies. He directed ministers to educate the public about both horizontal and vertical reservations in the DSC recruitment process.

The Chief Minister announced that the Veligonda Project would be inaugurated by the end of this month and said drinking water would be supplied to

the people of Prakasam district. He also asked ministers to create awareness among the public about the possible impact of El Niño, explaining that despite drought conditions, the government was ensuring drinking water supply.

Referring to the inauguration of Bhogapuram Airport, Chandrababu Naidu said the Thinsa tribal dance had earned a Guinness World Record for the first time. He said the airport's inauguration had created a strong emotional connect among the people of North Andhra and added that the public was happy with the government's performance. He also noted that the airport's landing approach had been designed over the sea. The Chief Minister in-



structed ministers to include the themes of "Swarnandhra" and "Viksit Bharat" in their Independence Day speeches. He further announced that Quantum Valley would be inaugurated in January.

'Disha' Never Became a Law

Speaking about the Disha Bill, Chandrababu Naidu

said it never became an actual law. He alleged that the previous government created unnecessary publicity by setting up Disha Police Stations and Disha vehicles despite the legislation never coming into force. He said the Central Government had returned the proposed Disha legislation without approval.

Be Prepared for Local Body Elections, Nara Lokesh Tells Ministers

From Our Staff Reporter Amaravati, August 6: Andhra Pradesh Minister for Education and Information Technology Nara Lokesh called upon ministers to prepare for the upcoming local body elections. Ahead of the Cabinet meeting on Thursday, Nara Lokesh held a breakfast meeting with ministers and urged them to ensure that NDA alliance candidates secure a majority of seats in the local body polls. He said the elections would be held as scheduled.

He asked ministers to explain to the people the destruction caused during the previous government and how the present coalition government had restored governance.



Nara Lokesh directed ministers to spend at least three minutes at every household to communicate the government's initiatives and achievements. The ministers also discussed issues to be taken up during the Assembly session. Nara Lokesh said the Assembly would be used as a platform to explain the El Niño situation and its possible impact to the public.

Proposal Sent for New Trains from Visakhapatnam : South Coast Railway GM Sandeep Mathur

Visakhapatnam, August 6: Sandeep Mathur, General Manager of the South Coast Railway Zone, said the railway administration is fully prepared for the Godavari Pushkaralu scheduled for next year. He stated that Rajahmundry, Godavari, and Kovvur railway stations are being upgraded in view of the religious event. Addressing the media in Visakhapatnam on Thursday, Sandeep Mathur said that the Visakhapatnam Railway Station is being modernized. As part of the project, six new railway platforms and six additional railway lines will be constructed. He also announced that a modern electronic signalling system will be installed. He said proposals have already been submitted for



launching more new trains from Visakhapatnam, and once approved by the Railway Board, the trains will begin operating with a regular schedule. He added that more train services are also being planned towards Ballari, while Tirupati continues to witness heavy passenger traffic. The General Manager said the automatic

signalling system is being upgraded in Vijayawada, and the Kavach train protection system is being installed on more trains to improve railway safety. Regarding the Kotipalli-Narasapuram Railway Line, Sandeep Mathur said some additional land is required from the state government and discussions are currently underway.

Strong effort to curb adulteration

On the one hand, increasing air pollution is a serious public health problem, while on the other hand, uncontrolled adulterated food is becoming deadly. On Tuesday (4.8.26), inspections were conducted at various places in Hyderabad city and 25.3 tons of adulterated spices and 89.15 tons of raw materials were seized. Three accused were arrested. The fact that the Hyderabad Food Adulteration Surveillance (HFAST) team conducted 659 raids and seized 254 tons of adulterated food in the 140 days since its formation shows how rampant the adulteration epidemic is in Telangana, especially in Hyderabad city. It is a good effort that the Telangana government is also preparing to form a Special Investigation Team (SIT) to crack this racket. According to a report by the Union Health Ministry, out of every 100 samples tested in Telangana in the last three years, 15 were found to be adulterated. Up to 168 deaths have occurred due to adulteration.

In Andhra Pradesh, 9 out of every 100 samples were found to be adulterated. Between February and March 2026, a total of 16 people lost their lives due to kidney failure due to adulterated milk in Rajahmundry, Andhra Pradesh, which caused a huge sensation. Southern states are at the forefront of cases of adulteration in food samples collected to detect adulteration across the country. Tamil Nadu is at the top with an average of 20 percent, followed by Telangana with 14 percent. Andhra Pradesh with 9 percent and Karnataka with 6.30 percent are next. In the last three years, more than 5.18 lakh food samples have been tested in the country and 88,192 people have been fined. Punishments have been imposed in 3614 cases. If you look at all this, you can see how adulteration is spreading like water under the carpet. Only by eating quality food can the brain and organs stay healthy

The Global Nutrition Report 2021 revealed that 12 million people died worldwide in 2018 due to unhealthy food made from adulterated ingredients. Milk, cheese, fruits, vegetables, and spices are adulterated, leading to serious health problems such as liver, kidney, heart diseases, and cancer for consumers. Adulteration is becoming institutionalized at the national level. Milk and water, which are the daily sources of people's livelihood, are filled with chemicals, damaging the quality of food. Antibiotics in poultry, and arsenic and lead in water have become dangerous.

Spices and cooking utensils also contribute to adulteration. A study conducted by Stanford University on the prevalence of the chemical element lead chromate in the country has revealed some facts. When samples were collected from 17 cities and examined, it was found that up to 14 percent of all the samples contained high levels of lead chromate metal. Lead residues were found to be high in the cities of Patna, Guwahati and Chennai. If we look at the dairy industry, half of the cooperatives in this are unorganized workers. They process ingredients like ghee. It is known how much controversy the Tirupati laddu adulterated ghee affair has created in the country.

Some field facts about ghee adulteration need to be mentioned. While the production cost of one kilo of ghee in the dairy industry is up to Rs. 550, someone sells adulterated ghee for Rs. 345 per kilo. Due to this, the farmer who produces genuine quality ghee is unable to compete with the adulterated trader. Since that ghee comes at a cheap price, consumers are inclined to buy it, but they are not aware of the fact that it is adulterated and harmful to health. That is why there is a need for awareness programs to be carried out by governments and NGOs so that consumers can clearly understand the differences between genuine and adulterated ghee. The Chhattisgarh and Maharashtra governments have banned the manufacture and sale of analogue paneer with the aim of curbing the manufacture and sale of adulterated milk products. Instead of using milk in the manufacture of analogue paneer, vegetable oil like palm oil, starch and milk powder are used. This is a great health hazard. Therefore, the Maharashtra government has warned that violating the ban on analogue paneer will result in six months in jail and a fine of Rs. 1 lakh, and the punishment will increase if someone dies due to eating analogue paneer. Authorities only raid if there are complaints of adulteration anywhere. Apart from that, there is a need to continue this movement continuously. Keeping public health in mind, FSSAI has launched a mobile application called Food Safety Connect. Through this, anyone can complain to the authorities about adulterated food. According to the Food and Safety and Quality Act 2006, the accused will be fined up to Rs. 1 lakh and sentenced to imprisonment for 6 to 7 years.

INTELLIGENCE BEHIND EVERY COMMAND



For nearly two decades, smartphones have been the primary gateway to the digital world. From sending messages and making video calls to shopping online, booking travel, managing finances, attending virtual meetings, and controlling smart homes, almost every digital interaction has revolved around opening applications, navigating menus, and manually completing tasks. This app-centric ecosystem revolutionized communication and transformed the mobile phone into one of humanity's most indispensable inventions. Yet, despite remarkable advances in hardware and software, the fundamental way people interact with smartphones has changed very little. Users still spend significant time switching between applications, searching for information, copying data from one platform to another, and coordinating multiple digital services to accomplish even moderately complex tasks.

Today, a new technological revolution is emerging that promises to redefine this relationship entirely. Instead of interacting with dozens of applications individually, users will increasingly communicate with intelligent systems capable of understanding their intentions and autonomously carrying out complex digital workflows. A single natural-language instruction could trigger hundreds of coordinated actions across multiple platforms, transforming smartphones from collections of applications into intelligent digital partners. This shift marks the beginning of the era of AI-first smartphones, powered by Large Language Models (LLMs), Agentic AI, and advanced multimodal reasoning systems. Unlike traditional virtual assistants that simply answer questions or execute isolated commands, Agentic AI introduces a fundamentally different approach to human-computer interaction. Rather than acting as passive tools, AI agents can understand objectives, reason through problems, create plans, interact with external software and services, monitor progress, adapt to changing circumstances, and complete tasks with minimal human intervention. Instead of asking, "What should I do next?" users will simply describe what they want to accomplish, leaving the AI to determine how to achieve it.

Consider a common business scenario. Imagine beginning your day by telling your smartphone, "Plan my business trip to Hyderabad next Monday. Book the earliest economical flight, reserve a hotel within five kilometres of the conference venue, arrange airport transportation, update my calendar, inform my project team, prepare the travel expense estimate, and remind me to carry the presentation materials." Accomplishing this task today requires opening airline applications, comparing prices, checking hotel availability, arranging transportation, switching to a calendar application, composing emails, calculating expenses, and coordinating information across multiple services. An AI-first smartphone would instead interpret the request, divide it into subtasks, communicate with authorized travel platforms, booking services, calendar applications, email systems, navigation tools, and payment services, before presenting the completed itinerary for user approval. The interaction shifts from operating software to expressing intent.

This represents one of the most significant transformations in the history of computing. For decades, technology has required people to adapt to machines by learning operating systems, application interfaces, icons, commands, and workflows. Agentic AI reverses this relationship. Computers increasingly adapt to humans by understanding natural language, recognizing context, remembering previous interactions, and making intelligent decisions. The interface is no longer the touchscreen-it is conversation itself.

The rapid advancement of Large Language Models has made this transformation possible. Modern AI models have evolved

far beyond text generation. They can analyze documents, understand images, interpret speech, generate computer code, reason through complex problems, summarize large volumes of information, and interact with users across multiple forms of communication. More importantly, recent generations of reasoning models are capable of planning sequences of actions instead of merely generating responses. This ability to think through multi-step problems allows AI to function as an autonomous digital assistant rather than a conversational chatbot.

However, language models alone are insufficient for building truly autonomous systems. Modern AI increasingly combines reasoning capabilities with technologies such as Retrieval-Augmented Generation (RAG), which enables AI to retrieve relevant information from trusted external knowledge sources before generating responses. Rather than relying solely on pre-trained knowledge, AI assistants can securely access enterprise databases, cloud storage, organizational documents, research publications, and personal files to produce more accurate, context-aware, and up-to-date results. This significantly reduces misinformation and allows AI systems to work effectively in business, healthcare, education, and research environments where current information is essential.

Equally important is the emergence of standardized communication frameworks that allow AI to interact with external tools and services. Protocols such as the Model Context Protocol (MCP) are enabling AI systems to securely communicate with calendars, email platforms, cloud storage, databases, productivity software, development environments, and enterprise applications through standardized interfaces. Rather than requiring developers to build separate integrations for every application, these protocols create a common language through which AI agents can discover tools, retrieve information, and execute authorized actions while maintaining conversational context. As these standards mature, AI assistants will become increasingly capable of coordinating digital ecosystems rather than operating within isolated applications.

Another important technological advancement is the shift toward on-device AI. Earlier generations of AI assistants relied almost entirely on cloud computing, requiring continuous internet connectivity and transmitting user data to remote servers for processing. Advances in mobile processors, Neural Processing Units (NPUs), and energy-efficient AI accelerators now allow increasingly sophisticated language models to run directly on smartphones. Local AI processing reduces response time, improves privacy, enables offline functionality, and minimizes dependence on cloud infrastructure. Future smartphones are expected to combine local intelligence with cloud-based reasoning, dynamically choosing where tasks should be processed depending on complexity, privacy requirements, and available computing resources.

The future of AI will not be driven by a single intelligent assistant alone. Instead, researchers increasingly envision ecosystems composed of multiple specialized AI agents working collaboratively. A travel agent may coordinate transportation and accommodation, a finance agent may monitor budgets and authorize payments, a scheduling agent may organize meetings, a research agent may gather information, while a communication agent manages emails and messages. Under the supervision of a central coordinating agent, these specialized systems will work together to accomplish complex objectives far more efficiently than a single monolithic assistant. This concept of collaborative multi-agent systems represents one of the most exciting frontiers in artificial intelligence research.

Beyond Smartphones-The Age of Ambient AI

The transformation driven by Agentic AI extends far beyond smartphones. Over the next decade, intelligence will no longer be confined to a single device carried in a pocket. Instead, AI will become an invisible digital companion distributed across an ecosystem of interconnected devices that understand context, share information securely, and collaborate continuously. This emerging paradigm, often referred to as ambient computing, aims to make technology less visible while making assistance more intelligent and proactive.

AI-powered wearables are among the first manifestations of this transition. Smart glasses, intelligent earbuds, smartwatches, and mixed-reality headsets are gradually evolving from accessory devices into always-available AI interfaces. Rather than requiring users to remove a phone from their pocket, future wearable devices will provide contextual information through natural conversation, voice interaction, gestures, or visual overlays. AI glasses, for instance, may identify landmarks during travel, translate foreign languages in real time, summarize meetings as they happen, recognize objects, retrieve relevant information from the internet, and provide navigation without requiring users to look at a smartphone screen. Similarly, AI-enabled earbuds could function as continuous personal assistants capable of answering questions, managing schedules, providing reminders, and facilitating multilingual conversations while remaining almost invisible during everyday activities.

This evolution reflects a broader shift from mobile computing to ubiquitous AI computing, where intelligence follows the user rather than remaining attached to a single device. Whether interacting through a smartphone, wearable device, vehicle, home assistant, or workplace computer, users will increasingly communicate with the same AI companion that remembers preferences, understands ongoing tasks, and maintains context across multiple environments. Instead of synchronizing data between devices, users will simply continue conversations with their AI assistant wherever they are.

Connected vehicles are also expected to become important participants in this intelligent ecosystem. Future automobiles equipped with Agentic AI may coordinate with smartphones, calendars, navigation systems, and smart city infrastructure to optimize travel routes, schedule charging for electric vehicles, reserve parking spaces, monitor vehicle health, and automatically notify colleagues if delays occur. A morning commute could become an extension of the user's digital workspace, allowing meetings to be prepared, emails to be summarized, research documents to be reviewed, and schedules to be reorganized through conversational interaction.

Smart homes will experience a similar transformation. Rather than controlling individual appliances separately, homeowners may simply communicate high-level intentions. A request such as, "Prepare the house for dinner guests at 7 PM," could automatically adjust lighting, regulate temperature, activate entertainment systems, coordinate robotic cleaning devices, order missing groceries, and even recommend recipes based on available ingredients. Instead of issuing multiple commands, users will define objectives while AI coordinates the necessary actions across numerous connected devices.

The implications of this technological transformation extend well beyond consumer convenience. In professional environments, Agentic AI has the potential to significantly enhance productivity by automating repetitive administrative tasks that currently consume valuable time. Knowledge workers frequently spend hours organizing files, preparing presentations, responding to routine emails, scheduling meetings, searching through documentation, and generating reports. Intelligent AI agents capable of understanding

organizational context could perform many of these activities automatically while allowing professionals to focus on strategic thinking, innovation, and complex problem-solving.

Software engineering provides an excellent example of this changing workflow. Modern developers already benefit from AI-assisted code completion and debugging, but future Agentic AI systems will assume much broader responsibilities. Engineers may instruct AI to analyze software requirements, generate application architectures, write initial code, create automated test cases, detect security vulnerabilities, review documentation, prepare deployment pipelines, monitor cloud infrastructure, and generate performance reports through a single request. Rather than replacing software developers, these capabilities will reduce repetitive tasks and allow engineers to concentrate on creativity, system design, and critical decision-making.

Researchers will experience similar benefits. Instead of manually reviewing hundreds of academic papers, organizing references, comparing methodologies, and identifying research gaps, AI agents could continuously monitor scientific publications, summarize newly published findings, identify emerging trends, generate literature reviews, recommend potential collaborators, and even assist in drafting research proposals. Such systems may dramatically accelerate scientific discovery while enabling researchers to devote more time to experimentation and original thinking.

Education represents another domain where Agentic AI could fundamentally transform learning experiences. Traditional educational systems generally provide standardized instruction despite significant differences in students' learning styles, prior knowledge, and career goals. AI-powered learning companions could personalize education by continuously evaluating individual progress, identifying conceptual misunderstandings, generating adaptive practice exercises, recommending supplementary learning materials, and adjusting teaching strategies according to each learner's pace. Engineering students, for example, could receive customized programming assignments based on previous coding errors, while medical students could practice diagnostic reasoning through interactive AI-generated clinical simulations. Personalized education of this kind has the potential to improve learning outcomes while making high-quality instruction more accessible across geographical and economic boundaries.

Healthcare is another area where AI-first devices could deliver transformative societal benefits. Continuous integration between smartphones, wearable sensors, electronic medical records, and intelligent monitoring systems may allow AI assistants to detect early indicators of disease, analyze long-term health trends, remind patients about medications, schedule medical appointments, interpret laboratory reports using understandable language, and alert healthcare professionals when unusual patterns emerge. Such systems could strengthen preventive healthcare by identifying potential risks before symptoms become severe. Nevertheless, AI should always function as a decision-support tool under the supervision of qualified healthcare professionals rather than as an independent replacement for clinical expertise.

Despite these remarkable opportunities, the rise of autonomous AI introduces equally significant challenges. The more authority users delegate to intelligent systems, the greater the importance of transparency, accountability, and trust. An AI agent capable of authorizing financial transactions, modifying business documents, sending emails, or accessing confidential information must demonstrate consistent reliability while clearly explaining its reasoning whenever significant decisions are involved. Human oversight must remain central to all high-impact applications involving healthcare, finance, law, education, and public administration. The goal of Agentic AI should be to augment human intelligence-not to eliminate human responsibility.

Privacy will become one of the defining issues of the AI-first era. Intelligent assistants require access to calendars, contacts, emails, messages, browsing histories, location data, personal documents, purchasing behavior, and digital preferences to provide meaningful assistance. This concentration of sensitive information creates enormous responsibility for technology providers. Future AI systems must therefore incorporate strong encryption, secure

identity management, transparent permission controls, confidential computing, and on-device processing wherever possible. Users should retain complete visibility into how their information is collected, processed, stored, and shared. Trust will ultimately become as valuable as intelligence itself.

Cybersecurity challenges will also evolve significantly. As AI agents gain the ability to perform autonomous actions across multiple services, they become attractive targets for cybercriminals. Compromising a single AI assistant could potentially provide unauthorized access to financial systems, enterprise networks, confidential communications, or personal identities. Consequently, future AI platforms will require advanced authentication mechanisms, behavioral anomaly detection, continuous monitoring, secure execution environments, and detailed audit logs capable of explaining every autonomous decision performed by an AI agent. Protecting AI systems will become just as important as improving their capabilities.

Perhaps the most profound transformation will occur within the software industry itself. For more than two decades, the digital economy has revolved around applications competing for users' attention through graphical interfaces. Agentic AI introduces an alternative model based on intentions rather than applications. Users may no longer search for specific apps to accomplish individual tasks; instead, they will describe desired outcomes while AI dynamically selects the most appropriate digital services in the background. This transition from an app economy to an intent economy has the potential to reshape software engineering, digital commerce, enterprise platforms, and mobile operating systems on a global scale.

From an engineering perspective, developing trustworthy Agentic AI represents one of the most ambitious interdisciplinary challenges in modern computer science. It requires advances in natural language processing, reasoning algorithms, multimodal learning, distributed systems, cybersecurity, edge computing, cloud infrastructure, human-computer interaction, software engineering, cognitive science, and AI ethics. Future engineers will therefore require not only strong technical expertise but also a deep understanding of responsible AI governance, legal compliance, privacy protection, fairness, transparency, and societal impact. Building intelligent systems that people can trust may ultimately prove more challenging than building intelligent systems that can reason.

The emergence of AI-first smartphones and autonomous digital assistants represents a transformation comparable to the arrival of the internet or the introduction of the smartphone itself. Future innovation will no longer be measured primarily by faster processors, larger displays, or higher-resolution cameras. Instead, the defining characteristic of next-generation computing will be the ability of intelligent systems to understand human intentions, collaborate across digital ecosystems, and execute complex tasks responsibly with minimal effort from the user.

In the years ahead, people may no longer ask, "Which application should I open?" Instead, they will simply describe what they want to achieve. Behind a single sentence, dozens-or even hundreds-of coordinated AI agents may securely communicate with cloud services, enterprise platforms, smart homes, vehicles, wearable devices, and digital assistants to transform human intentions into completed actions within seconds. Yet amid this extraordinary technological progress, one principle must remain constant: Artificial Intelligence should amplify human capability, not replace human judgment. The smartest device will never be the one that makes every decision independently, but the one that empowers its user through intelligence, transparency, security, and meaningful human control.

South Coast Railway Records Strong Start with Major Milestones in Two Months



Visakhapatnam, pen power Aug. 6: South Coast Railway (SCoR), which became operational on June 1, 2026, has registered an impressive beginning by achieving significant progress in infrastructure development, passenger services, safety, and operational performance within just two months, General Manager Shri Sandeep Mathur said while reviewing the Zone's performance. Established as the country's newest railway zone, South Coast Railway has built its administrative and operational framework from the ground up. The Zone now comprises four divisions, covering 3,532 Route Kilometres and 6,455 Track Kilometres, with an expected annual originating revenue of Rs.15,500 crore and freight loading exceeding 100 million tonnes. Highlighting safety as the Zone's highest priority, the General Manager said senior railway officials inspected nearly 1,700 Route Kilometres over the past two months to strengthen safety standards and review ongoing infrastructure works.

The Zone is currently executing 29 major infrastructure projects, including five new railway lines and 24 multi-tracking works, with investments worth Rs.54,479 crore, while projects valued at Rs.70,865 crore are in the pipeline. More than 300 Road Over Bridges (ROBs) and Road Under Bridges (RUBs) are also under construction to improve connectivity and public safety.

Among the major achievements, South Coast Railway secured approval for the Rs.300-crore Visakhapatnam Yard Remodeling Project, the Rs.1,205-crore Guntakal-Ballari Quadrupling Project, and Rs.20 crore for crowd management facilities at Tirupati. The Zone also commissioned important works, including yard remodelling at Narsapur-Vijayawada and Garudaballi-Visakhapatnam, expanded Automatic Block Signalling in the Nellore-Telamanchi section, and installed the Kavach safety system on nearly 100 locomotives. Passenger amenities have also received a major boost. Three redeveloped Amrit Bharat Stations—Rayanapadu, Mangalagiri, and Cumbum—have been inaugurated, while redevelopment work is progressing at 70 additional stations. Plans are also underway for third and



fourth railway lines and extensive yard remodelling at Simhachalam North and Renigunta to ease congestion.

To improve passenger convenience, South Coast Railway converted four Train-on-Demand services into regular trains, operated 76 special trains benefiting around 86,000 passengers, attached 408 additional coaches, and upgraded the Simhadri Express and Guntur-Vikarabad Express to modern LHB coaches. Sleeping Pods have also been introduced at Vijayawada Railway Station, while premium "Deccan Chai" catering services have commenced at Visakhapatnam Railway Station. On the security front, the Railway Protection Force detected 28 NDPS cases and seized narcotic substances worth Rs.2.37 crore during the first two months. Cleanliness drives were intensified across stations, particularly at Visakhapatnam, while action was taken against 5,152 offenders to maintain discipline and cleanliness. Operationally, the Zone recorded Rs.671 crore in originating passenger revenue, handled 29.4 million originating passengers, registered 3% annual passenger growth, and achieved total originating earnings of Rs.2,493 crore, placing South Coast Railway among the country's better-performing railway zones.

The General Manager said the Zone has also adopted a fully digital e-Office system from its first day of operations and established employee welfare, sports, cultural, and recognized union bodies. He reiterated that South Coast Railway remains committed to strengthening safety, accelerating infrastructure development, enhancing passenger facilities, and delivering efficient, customer-centric railway services while contributing to the socio-economic growth of Andhra Pradesh and the nation.

'Maharashtra FDA Labs Must Operate 24x7 If Needed, Employees Can Quit If Unwilling': Tukaram Mundhe

FDA LABS MUST WORK 24x7, EMPLOYEES CAN QUIT IF UNWILLING: MUNDHE

Maharashtra FDA Commissioner Tukaram Mundhe defends extended laboratory shifts, says government labs may eventually operate round the clock for faster testing and timely regulatory action.

Mumbai: Defending the Maharashtra Food and Drug Administration's (FDA) decision to extend laboratory working hours, Commissioner Tukaram Mundhe said government laboratories testing food and drug samples must eventually function round the clock, asserting that employees unwilling to work under the revised system are free to resign. His remarks came after 29 officers and employees of the FDA laboratory in Chhatrapati Sambhajnagar submitted a complaint to FDA Minister Narhari Zirwal, alleging excessive workload, compulsory duties on weekends and public holidays, and acute staff shortages. In their representation dated July 15, the employees opposed the newly introduced two-shift system under which the laboratory functions from 7 am to 3 pm and 12 noon to 8 pm, replacing the earlier office hours of 9.45 am to 6.15 pm. They claimed the re-

vised schedule, which includes work on Saturdays and occasionally Sundays and public holidays, has disrupted their work-life balance. Rejecting the allegations, Mundhe said the new arrangement does not increase individual working hours. "Each employee works only one eight-hour shift a day. No one is being asked to work beyond 48 hours a week, which is in line with International Labour Organization (ILO) norms. Employees are also given one weekly holiday," he said. He stressed that government laboratories cannot function like regular offices. "Laboratories cannot operate only from 10 am to 6 pm. At present, we have introduced two shifts, six days a week. We have not yet started 24x7 operations, but if the need arises, laboratories will have to function round the clock to ensure faster testing and timely regulatory action." Dismissing the employees' demand to restore the

earlier working hours, Mundhe said it was "completely unacceptable." "It is not possible to restrict laboratory timings to office hours. Those who are unwilling to work according to government rules are free to resign and leave," he said. The employees, however, maintained that the laboratory is facing a severe shortage of analysts, laboratory assistants, technical personnel, and support staff, making it difficult to

process samples according to Indian, British, and United States Pharmacopoeia standards while clearing a growing backlog. Mundhe attributed the increased workload to the FDA's intensified crackdown on food adulteration and unsafe products across Maharashtra, which has sharply increased the number of samples reaching state laboratories, making faster testing essential for effective public health enforcement.

Andhra Pradesh Medical Student Declared Brain-Dead After Car Runs Over Her Outside Rajahmundry Mall

Rajahmundry : A young woman was declared brain-dead after a car allegedly ran over her outside a mall in Rajahmundry, Andhra Pradesh. According to reports, the victim, a 28-year-old medical student of a private medical college, was allegedly run over by a car following a confrontation with two drunk youths. The incident reportedly took place on AV Appa Rao Road under the Prakash Nagar

police station limits. According to police, two drunk youths arrived at the mall and got into an argument with security personnel over some issue. Police suspect that the duo drove away from the mall in an agitated state, during which their car allegedly struck Priyanka, who was outside on the road. The vehicle is said to have run over her head, causing severe head injuries.

SP Redefines 'P' In PDA As Pandit: Why Akhilesh Yadav Is Recalibrating His Brahmin Outreach

Lucknow: Samajwadi Party president Akhilesh Yadav has begun recasting one of his party's most successful political slogans. The "P" in the PDA formula, which originally stood for Pichhra (Backward), is now increasingly being projected as Pandit, signalling a strategic attempt to bring Brahmins back into the SP fold ahead of the 2027 Uttar Pradesh Assembly elections. The shift marks one of the most significant ideological and electoral recalibrations by the SP since it coined the PDA, or Pichhra, Dalit, Alpsankhyak, narrative before the 2024 Lok Sabha elections. That formula helped the INDIA bloc win 43 of Uttar Pradesh's 80 Lok Sabha seats and reduced the BJP's tally sharply. With the Assembly election now less than a year away, the party appears to believe that expanding the social coalition is more important than preserving the original slogan. The new messaging became evident on Wednesday when Akhilesh Yadav celebrated the birth anniversary of Janeshwar

Mishra at the party headquarters and repeatedly referred to the "P" in PDA as "Pandit". He paid floral tributes to Mishra's statue and launched a sharp political attack on the BJP over the alleged theft of donations at the Ram Temple in Ayodhya. He also accused the BJP of failing to give adequate representation to Brahmins and claimed the community's self-respect had been undermined. The symbolism was deliberate. Janeshwar Mishra, popularly known as "Chhote Lohia", remains one of the tallest Brahmin socialist leaders and continues to command respect across ideological lines. By placing Mishra at the centre of its latest campaign, the SP is attempting to reassure Brahmins that the party values both their political contribution and leadership. The Ram Temple issue has also become an important instrument in this outreach. Rather than opposing the temple, Akhilesh has chosen to question the BJP's management of the shrine, alleging corruption in donation collections and de-

manding accountability. This enables the SP to engage with a religious issue without appearing anti-Hindu, a criticism the BJP has frequently levelled against it. Political observers see the shift as an acknowledgement of electoral arithmetic. While the PDA alliance of OBCs, Dalits and Muslims remains the SP's core support base, party strategists believe it may not be sufficient on its own to secure a majority in the 403-member Assembly. Winning over even a section of Brahmin voters, estimated at around 10-12 per cent of the state's electorate, could prove decisive in closely contested constituencies. The outreach is also aimed at exploiting signs of discontent within sections of the Brahmin community. Over the past few years, opposition parties have repeatedly accused the BJP of sidelining Brahmin leaders, though the BJP rejects the charge. By highlighting issues such as the Ram Temple donation controversy and the alleged lack of representation, the SP



hopes to create political space among upper-caste voters without alienating its traditional support base. For now, Akhilesh Yadav's message is unmistakable. The PDA formula that reshaped Uttar Pradesh politics in 2024 is being broadened. By redefining the "P" from Pichhra to Pandit, the Samajwadi Party is signalling that the battle for 2027 will not only be about consolidating backward classes, Dalits and minorities, but also about making inroads into a community that has traditionally leaned towards the BJP. Whether this social engineering succeeds could play a crucial role in determining the outcome of Uttar Pradesh's next Assembly election.

Fans Used To Fry Lucknow-Kanpur Expressway As Rain Exposes Road Damage; Akhilesh Targets CM Yogi Adityanath Govt



Lucknow: Barely three weeks after its inauguration, the Rs 4,200 crore Lucknow-Kanpur Expressway has come under intense scrutiny after heavy monsoon rains exposed potholes, surface subsidence and cracks at several locations, forcing emergency repairs and triggering a political slugfest in Uttar Pradesh. The controversy escalated after videos showing workers using large industrial and pedestal fans to dry a waterlogged stretch of the expressway near Begumkhed village in Unnao district went viral on social media. The unusual method, adopted to speed up repair work on rain-soaked pavement, drew widespread criticism and sparked a flood of memes online. Lucknow - Kanpur Expressway was constructed at Rs.67 Cr per kilometre. Totally Government of India spent 74200 Cr on this 63 Cr stretch. It was inaugurated three weeks ago. This is the condition of the road after opening. Samajwadi Party president Akhilesh Yadav seized on the episode to attack the Yogi Adityanath government, questioning the quality of construction on a highway that had been opened only weeks earlier.

Sharing the viral video on social media, Yadav said it was astonishing that an expressway inaugurated with much fanfare was already being patched and dried with fans. "This is the new wind of BJP's development," he remarked, alleging that the incident exposed poor workmanship and raised serious concerns over the safety of commuters. The 63-km access-controlled expressway, inaugurated on July 13, was built to reduce travel time between Lucknow and Kanpur. However, the first signs of trouble emerged on the night of July 26, just 13

days after it was opened to traffic, when sinking, surface slippage and erosion were reported on a stretch in Unnao district following heavy rainfall. Since then, repair work has been underway at multiple locations. Excavators and other heavy machinery have been deployed to remove damaged sections and reconstruct the pavement. During one such repair operation near kilometre 64, workers were seen using industrial fans to dry the road surface before laying fresh material, visuals that quickly went viral. The National High-

ways Authority of India (NHAI) has initiated action against the construction company, PNC Infratech, over the defects. Three engineers associated with the project have been removed, while certain site officials have also been replaced. NHAI has suspended toll collection on the expressway until repairs are completed and the road is declared fit for traffic. The authority has also decided to seek an independent technical assessment from IIT Kharagpur to determine the reasons behind the premature damage and recommend corrective measures. The incident has intensified questions over the quality of construction and monitoring of major infrastructure projects in the state. Opposition parties have demanded accountability from both the contractor and officials responsible for supervising the project, arguing that a newly built expressway developing structural defects within weeks of opening raises serious concerns about construction standards and public safety.

BJP MLA Says He Feels 'Cheated' As Son-in-Law's Father Faces Charges Of Marrying 25 Women

Lucknow: Seuta MLA Gyan Tiwari on Thursday said he felt "cheated" after allegations surfaced against his samdhi (the father of his son-in-law), Anuj Trivedi, who has been accused of marrying and allegedly duping 25 women across several states. Appearing in a Facebook Live session alongside his daughter, Dr Pragya Tiwari, the legislator said he no longer wished to maintain any relationship with the family and demanded strict action against Trivedi. According to reports, Trivedi, a resident of Chandrawal in Uttar Pradesh's Misrikh area, is currently in jail in connection with a case registered in Mumbai. Several women have accused him of deceiving them by entering into marriages under false pretences between 2016 and 2021. The MLA said that he had arranged his daughter's marriage to Trivedi's son, Prakhar, in 2024 after receiving recommendations from several prominent people, including former MP Janardan Mishra. He claimed that he had been informed that the family was involved in the real estate business. Tiwari alleged that he later discovered details of multiple criminal cases against Anuj Trivedi and said he now regretted the decision. The legislator also claimed that allegations had been levelled against his son-in-law, Prakhar, although no official confirmation has been made regarding those claims. During the social media interaction, Tiwari demanded the strictest possible punishment for those found guilty.

Temasek-Backed Shiprocket Fixes Rs.92-97 IPO Price Band For Rs.1,617.5 Crore Issue

New Delhi: Temasek-backed e-commerce enablement platform Shiprocket Ltd on Thursday fixed a price band of Rs 92-97 per share for its Rs 1,617.5 crore Initial Public Offering (IPO), which will open for subscription on August 12. The initial share sale will conclude on August 14, while the bidding for anchor investors will open for a day on August 11, the company said in a public announcement. The IPO comprises a fresh issue of equity shares aggregating up to Rs 885.50 crore and an Offer For Sale (OFS) component worth up to Rs 732 crore. As part of the OFS, existing shareholders Lightrock, Tribe Capital, Moore Strategic Ventures, Agility International Investment, Gautam Kapoor, Saahil Goel and Vishesh Khurana will dilute their stakes in the company.



Tragic! Class 10 Student Collapses, Dies During Volleyball Match In Karnataka's Dakshina Kannada; Terrifying VIDEO Surfaces

Bengaluru: In a tragic incident, a 15-year-old Class 10 student died after suddenly collapsing while playing a volleyball match with his friends in Karnataka's Dakshina Kannada district. The tragic incident was caught on camera and the video is being widely shared on social media. There are reports that the tragic incident took place at a playground in Surinje near Surathkal and was captured on CCTV. The student has been identified as Likhith Amin, who was studying in Class 10 at the Government High School in Kote Bollaru, Surinje. Likhith was enjoying a game of volleyball with his friends when he suddenly collapsed on the court. The CCTV footage shows him serving the ball and moving towards the net to return the next shot. Moments later, he raises his hands before collapsing to the ground. His friends are seen rushing to help him after he falls. People present at the playground immediately took Likhith to a nearby hospital. However, the doctors declared him dead. The exact cause of his death is not yet known. As per reports, the police said that the reason will be confirmed only after the post-mortem examination report is received. The sudden death cases of youngsters while playing, dancing, walking and running are on the rise in the country and the government should take the incidents seriously and must take steps to curb such tragic incidents in the future.

Its core business comprises the domestic shipping platform and shipping apps, offering end-to-end shipping solutions in India, including multi-modal transportation, AI-based logistics allocation, order management and tracking tools. The emerging business houses newer offerings such as cargo and fulfilment services, cross-border shipping, advertising and marketing solutions, capital solutions and hyperlocal deliveries, aimed at helping merchants expand and scale their operations. Shiprocket operates an asset-light business model, with a scalable technology platform at the core of its operations, supplemented by an extensive network of ecosystem partners. As much as 75% of the offer has been reserved for Qualified Institutional Buyers (QIBs), 15% for Non-Institutional Investors (NIIs) and the remaining 10% for retail investors. The company had filed its draft IPO papers with Sebi through the confidential pre-filing route in May and subsequently received the regulator's approval in November to launch the public issue. The company's shares are proposed to be listed on the BSE and NSE on August 19. Axis Capital, BofA Securities, JM Financial and Kotak Mahindra Capital Company are the book-running lead managers to the issue, while KFin Technologies is the registrar.

Coal Supply Position for Power Sector Remains Adequate; Production and Despatch Register Strong Growth in July 2026

New Delhi, August, 6 (PIB): The country's coal supply position for the power sector continues to remain adequate, backed by robust growth in production, despatch and receipts during July 2026. The overall coal production during July 2026 stood at 69.75 Million Tonnes (MT), as against 64.88 MT during the corresponding period last year, registering a growth of 7.51%. Overall coal despatch during the month stood even higher, at 86.85 MT compared to 73.58 MT in the same period last year, marking a robust growth of 18.03%. The coal receipt at thermal power plants during July 2026 stood at 68.83 MT, as against 60.69 MT in July 2025, registering a growth of 13.41%. This sustained and healthy growth in supplies to the power sector underscores the Ministry's continued focus on ensuring uninterrupted coal availability to meet the nation's energy requirements, with the continued support of Indian Railways. As on 04.08.2026, the coal stock at thermal power plants stood at 34.55 MT. In addition, about 113 MT of coal is available at pitheads and in transit, taking the total available stock to approximately 148 MT.

SAI faces 554 coaching vacancies, says Sports Minister Mansukh Mandaviya



New Delhi: Over 500 vacant coaching positions in the Sports Authority of India (SAI), increased dope tests at the grassroots level and funds provided to football's beleaguered national body were among the diverse issues that Sports Minister Mansukh Mandaviya addressed in his responses to various Rajya Sabha queries. Despite the launch of a mega recruitment drive by SAI in January to hire more than 350 assistant coaches, 464 positions remain vacant, a number which is over 100 more than last year. In all, 554 positions are waiting to be filled, including 90 slots for head coaches at its facilities across the country. "The qualifications and competencies of coaches are assessed in accor-

dance with the prescribed recruitment and engagement norms," Mandaviya stated. The minister also revealed that in the last five years, Rs 8.5 crore has been allocated for training and upskilling programmes for coaches to "enhance their professional capabilities. Mandaviya's statement was in written response to a query from the Leader of the Opposition in Rajya Sabha and Congress President Mallikarjun Kharge.

Measures to counter doping

In response to a query from BJP MP Kesridevsinh Jhala on the anti-doping measures taken by the government, Mandaviya cited the NADA's dedicated intelligence and investigation mechanisms to collect, and assess information

relating to potential Anti-Doping Rule Violations (ADRVs), including trafficking, administration, possession and distribution of prohibited substances and methods. The minister said that the number of sample collection sessions at grassroots-level events, including school, university, state, and zonal-level events has also gone up. "A total of 20 sample collection sessions were conducted in 2025, and 55 sample collection sessions have been conducted in 2026 up to July 2026," he noted. In addition, the Sample Collection Personnel (SCP) workforce has also been strengthened through "regular recruitment, training, and re-accreditation programmes." "A total of 11 training programmes were con-

ducted in 2025, and four training programmes have been conducted in 2026 up to July 2026, to ensure the availability of qualified sample collection personnel across different regions of the country," he said. The government is also pushing for criminalisation of doping by proposing jail term and fines for entities indulging in trafficking and supply of prohibited substances in fresh amendments to the National Anti-Doping Act.

The football crisis

A couple of questions were posed on the state of Indian football as well. They focussed primarily on the central government's efforts to keep the sport afloat as it goes through a commercial crisis alongside lack of credible international performances. Mandaviya stated that the government has provided financial assistance to the tune of Rs 37.98 crore in the last five years. This year a total of Rs 3.91 crore has been provided to the All India Football Federation (AIFF) from a total allocation of Rs 8 crore. "At present 527 athletes of football discipline are being trained at various SAI centres across the country," read the minister's statement. "SAI, an autonomous body under the aegis of the Ministry of Youth Affairs and Sports, regularly engages with the AIFF to review the performance and overall development of the sport and provides its advice accordingly," it added.

Argentina to observe National Football Teams Day every July 15 after 2026 World Cup triumph

Buenos Aires: Argentina has officially declared July 15 as 'National Football Teams Day', commemorating the national side's dramatic victory over England in the 2026 FIFA World Cup semi-final and extending the tribute to every national team representing the country. The decision was approved unanimously during the Executive Committee meeting of the Argentine Football Association held at its training centre in Ezeiza. The date marks Argentina's memorable 2-1 comeback victory over England in the 2026 FIFA World Cup semifinal. After falling behind to Anthony Gordon's second-half strike, Lionel Scaloni's side fought back through an 85th-minute equaliser from Enzo Fernandez before Lautaro Martinez scored the winner in stoppage time to book a place in the final. Explaining the decision, the AFA said, "The date was chosen to commemorate Argentina's historic victory over England in the 2026 World Cup semifinal. Lionel Scaloni's team was trailing England by a single goal, but with goals from Enzo



Fernandez and Lautaro Martinez, they turned the game around, sending the entire nation into a frenzy of celebration." The federation said the tribute was not limited to the senior men's team. "The recognition also extends to each and every one of the national teams, including youth, men's and women's, futsal, beach soccer and field football, who train every day at the Lionel

Andrés Messi training complex with the hope, joy and responsibility of representing Argentina," the statement added. The semifinal was one of the defining matches of the tournament and was followed by controversy after some Argentina players celebrated with chants and posters referencing the Falkland Islands, known in Argentina as the Malvinas. The celebrations drew criticism in England and

reignited debate over the long-standing sovereignty dispute between the two nations, although the result on the field remained one of Argentina's most celebrated World Cup victories. The newly established National Football Teams Day will now be observed annually to celebrate the achievements and commitment of all Argentine national teams across football disciplines.

Brijesh Sharma joins Jammu & Kashmir squad ahead of 2026/27 domestic season

New Delhi: Fast bowler Brijesh Sharma has joined the Jammu and Kashmir squad for the upcoming 2026/27 domestic season. Brijesh hails from Mada town in Udhampur district and came into the limelight after making his IPL debut for Rajasthan Royals earlier this year. Though Brijesh had registered as a Cricket Association of Bengal (CAB) player for the Indian Premier League (IPL) 2026 auction, he's now all set to turn out for his home state Jammu and Kashmir, the current Ranji Trophy holders. "Yes, Brijesh Sharma has linked up with the Jammu & Kashmir team for the preparation camp and has been progressing well," said a well-placed source in the Jammu & Kashmir Cricket Association (JKCA) to IANS on Thursday. Re-

cently, Brijesh was named in J&K's list of players who will play practice games against Uttarakhand from August 10-17 at the SK Stadium in Srinagar, with both teams set to report to the city on August 8. Brijesh played for J&K age-group teams before relocating to Delhi to train under coach Deepak Punia, who was a former pacer in the Ranji Trophy. He earned his IPL contract on the back of a strong showing in the 2025 Bengal Pro T20 League, where he took 11 wickets in seven games for Smashers Malda.

In IPL 2026, Brijesh picked up 14 wickets in 13 games in his debut season for Rajasthan Royals (RR), who acquired him at a base price of Rs 30 lakh despite his not having played senior domestic cricket before the tournament. Meanwhile,



regarding replacements among the Jammu and Kashmir coaching staff, IANS understands that official word is yet to come. With head coach Ajay Sharma around, the side needs replacements for bowling coach P Krishnakumar and fielding coach Dishant Yagnik, who have moved to be coaches at the BCCI Centre of Excellence (CoE) in Bengaluru. Former

Delhi wicketkeeper-batter Punit Bisht, who was Jammu and Kashmir U23 men's head coach, could be promoted to the senior team coaching staff. A search for a suitable replacement for Krishnakumar, who has played an instrumental role in the side becoming a force to be reckoned with in the red-ball format and in the rise of pacer Auqib Nabi, is still on.

Gautam Gambhir tells Team India to be ready from day one ahead of Sri Lanka Test series



Colombo: India head coach Gautam Gambhir has urged the Shubman Gill-led Test squad to be mentally and physically prepared to tackle any challenge right from the opening day of the upcoming two-game series against Sri Lanka, starting in Galle on August 15. The Indian team began its practice session at Colombo's NCC ground morning, and are scheduled to play a three-day practice match at the same venue from August 7-9. Following this, the visitors will head to Galle for the series opener on August 15. The second and final Test is scheduled to be played at the historic Sinhalese Sports Club (SSC) from August 23 to 27. "Guys, we know what's in front of us. We know what we are playing for. We can do the volume, we can push our limits, we can tick all

the boxes. Come 15th morning, whether we are batting first, or whether we are bowling first, we're absolutely ready with every answer, every question that's thrown at us and every answer we're ready to give. So make sure we tick all the boxes from now on," said Gambhir in a video shared by the Board of Control for Cricket in India (BCCI) on their official social media handles on Thursday. India's current standing in the World Test Championship (WTC) is at fifth with a points percentage (PCT) of 48.150, while Sri Lanka is at sixth spot with 41.67 PCT. Gambhir also took the opportunity to officially welcome newcomers, off-spin bowling all-rounder Saransh Jain and pacer Auqib Nabi to the Test setup, alongside the newly appointed field-

ing coach, Subhadeep Ghosh. "Guys, welcome everyone. We've got a couple of new guys in. To start with, Saransh, congratulations, you've worked extremely hard to be here. Make sure that you make your family and country proud whenever you get that opportunity. "Secondly, I want to congratulate Auqib, you had a phenomenal last season, and made J&K win the Ranji Trophy, which is a great achievement. Congratulations once again. Lastly, I want to welcome Joy as well. "He's worked with so many teams for so many years. 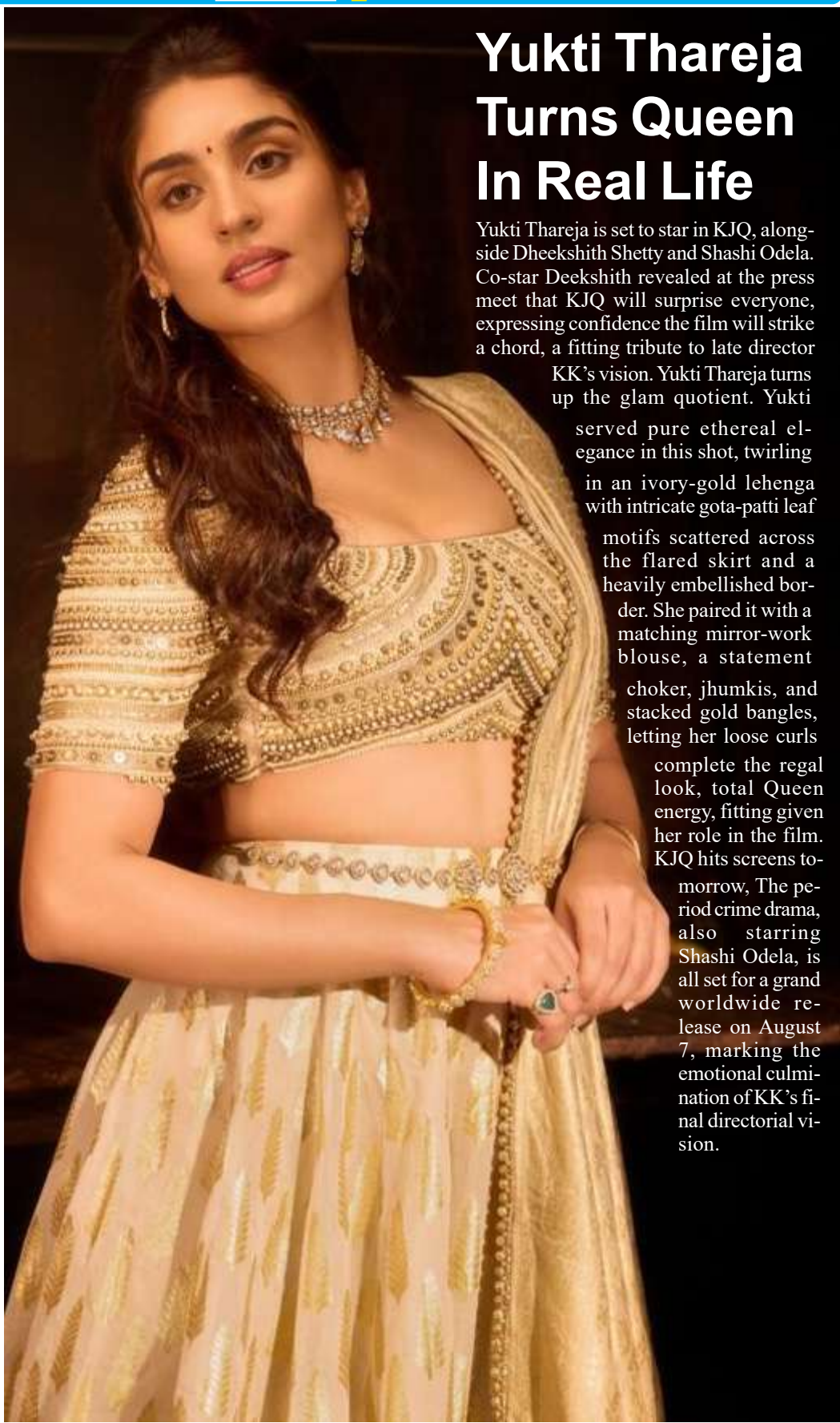
